## Proposed Microsoft settlement receives early approval

SEATTLE -- A California state judge on Friday gave preliminary approval to a \$1.1 billion proposed settlement between Microsoft Corp. and California consumers over alleged violations of the state's antitrust laws.

Consumers can now file claims under the settlement, which requires Microsoft to provide \$1.1 billion in vouchers for computer and software purchases from Microsoft or rival vendors. They can call 1-800-203-9995 to file their claims.

Two-thirds of any unclaimed portion of the settlement amount will go to California's poorest schools in the form of software, hardware and money for technology programs, under the terms of the agreement.

A hearing on final approval is expected early next year, said Microsoft spokesman Jim Desler. Microsoft has reached agreements with five of 17 states that have pressed class-action suits.

The lawsuits are separate from the antitrust lawsuit filed against

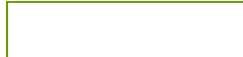

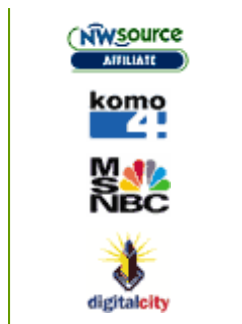
